LISTENING Section 1

1 Answer: Grieves/Anna

Note The form requires last and first names. The woman gives both, and in this case in that order. She spells out her last name and confirms the double 'N' in 'Anna'.

2 Answer: Holiday World

Note The man asks Anna 'where you heard about' Go-Travel, which matches 'source of enquiry' on the form. Anna's reply ('it was your advertisement') matches 'saw ad', 'Magazine' is written on the form, so you should not repeat it, particularly since you are told to write no more than two words.

Answer: FT4551

Note 'Reference' matches 'code' on the recording. You need to be prepared for the various ways of saying such combinations of letters and numbers.

Answer: 3

Note Anna and two friends makes a total of three. Mathematics is not necessary, as you are told the actual

5 Answer: August 16

Note Anna also refers to the 'end of August', but this is when she needs to return by, not when she needs to depart ('going

6 Answer: 11

Note Darren mentions three possible numbers of nights, out of which Anna chooses 'the middle one'.

Answer: Super

Note Darren lists three available types ('levels') of insurance. Anna rules out the first, Standard, and selects ('let's say') Super.

8 Answer: G

Note Having said no to option E, picnic lunches ('we'd leave that'), Anna agrees to option G ('is a must').

Answer: A

Note Anna says no to option D ('we'll pass on the night bus one') and option C ('museums aren't really my sort of thing'). But she says yes to option A ('the demonstration of local arts could be fun').

Answer: F

Note Anna says yes to option F ('sounds delightful ...'), but says no to option H ('well, sitting in a coach on those winding roads ... '), which Darren confirms with 'I understand'.

LISTENING Section 2

11 Answer: 1992

Note It is important to read the page of notes you are required to complete carefully. Question 11 is about when the charity was 'set up'. The recording mentions 1987 (when the founder took up running) and 1997 (when the runs were being filmed). It is in 1992 that the charity was 'set up' ('established').

12 Answer: hospital

Note 'Aim' matches 'with the idea that' on the recording. The money goes to the hospital; people who are unwell will then (presumably) benefit.

Answer: numbers

Note This is the correct answer, which fits the space both grammatically and logically. Neither 'ideas' nor 'standard' would fit. Here, 'supply' matches 'reproduce' on the recording.

Answer: train

Note The space requires a verb, and one that can go before 'together'. We are told that teams do not 'compete side by side' but that they 'should' ('we do recommend') 'train as a

Answer: food and drink

Note The space requires a noun or nouns. You should not try to make 'eat and drink' fit, but you must write 'food and drink'. 'Enough' matches 'sufficient' on the recording.

Answer: main square

Note You need to pay attention to prepositions here. 'In' goes only before 'main square' on the recording. The 'race' ('course') goes 'through' the town and park. 'Finish' matches 'concluding' on the recording.

Answer: minister for health

Note The note here is about who gives the prizes. One prize (only) has been donated by Zoom Fashions. The Mayor will make a speech, but does not give the prizes to the runners only the Minister for Health does that.

Note Option C is recommended: 'A sponsored swimming event ... did very well'. Options B and F are not recommended, although they are mentioned on the recording: 'Selling home-made cakes and bread' and 'a large picnic' 'failed to justify the efforts put into them'.

Answer: A

Note Option A is recommended: 'It is possible to raise useful funds by selling ... badges'. Option G is neither recommended nor advised against (and so does not answer the question correctly): 'We're currently checking to see'. Option I is not recommended: 'The returns have not been very high on this'.

Answer: H

Note Option H is recommended: It 'went very well, and it would be good to see more such activities'. Option D is neither recommended nor advised against (and so does not answer the question): 'We'll have to see how plans for that progress'.

LISTENING Section 3

Answer: A

Note The question matches 'people's names in terms of culture' on the recording. The conclusion to include this is reached across things that all three speakers say.

22 Answer: B

Note The question matches 'ways in which naming practices are similar across different languages' on the recording. Joe expresses reservations about this ('not sure ... ') which Angela supports ('maybe you need ... '), so its inclusion is neither sure nor ruled out.

23 Answer: A

Note The question matches 'what first names mean' on the recording. All three speakers express enthusiasm about the idea, and Joe confirms its inclusion by saying he will enjoy creating the projection slides for it.

24 Answer: C

Note The question matches 'place names' and 'sea ... ' on the recording. Martin is critical of the suggestion, and Joe concedes ('perhaps you're right'), so the conclusion is that it will not be included.

25 Answer: B

Note The question matches 'the way migrants often used to name places after somewhere in their country of origin' on the recording. Martin is critical or doubtful about its inclusion, and Angela and Martin agree that he should wait until he decides whether to include it or not – in other words, he might include it.

26 Answer: A

Note The question matches 'country names, the origins of those' on the recording. All three speakers find this interesting, and Joe's idea of projecting a map of the world during the presentation is supported ('that seems a foregone conclusion'), so that it is clear this topic will definitely be included.

27 Answer: meaningless words

Note 'Many' words in the summary matches '108 words' and 'the list' on the recording. Once you have identified 'common' in the summary as matching 'ordinary' on the recording, the sequence of types of words is clear.

28 Answer: capital letters

Note 'Shown' in the summary matches 'displayed' on the recording; 'easier' matches 'more readily'; 'identify' matches 'recognise'.

29 Answer: colour/color

Note 'Visual features' on the recording introduces the thing you need to focus on. 'Helping to store ... ' on the recording matches with this sentence in the summary. Because you only write two words, you should not try to include 'for example' from the recording.

30 Answer: associations

Note 'Create' in the summary matches 'conjure up' on the recording; 'within' matches 'inside'; 'a number of' matches 'a range of'.

LISTENING Section 4

31 Answer: spies

Note After the introduction, 'US civil war' in the notes is repeated on the recording. The idea of 'replacing' on the recording matches 'instead of' in the notes. It would be wrong to think that something like 'enemy lines' was being replaced.

32 Answer: maps

Note You must find a word or two words that fit grammatically as well as logically into the space. The verb 'to make' in the notes matches 'were employed in the creation of' on the recording.

33 Answer: collect data

Note This is what fits the space in the notes in terms of grammar and meaning. There are references to 'knowledge and understanding' on the recording, but they are not precise enough for the space you must fill.

34 Answer: climate

Note Something that is 'part of studies of' matches the idea of 'ongoing investigations into' on the recording. 'Instruments' are used to carry out this research, but are not, in this sense, part of 'the studies'.

35 Answer: lift

Note There are various comparisons going on or implied here – 'cheaper and safer', but 'create' in the notes matches 'generate' on the recording. You need to process the transfer from 'less' to (not) 'as much as'.

36 Answer: weather protection

Note 'The first airships' matches 'early examples' on the recording. 'Had no' matches 'didn't provide any'.

37 Answer: framework

Note 'Be efficient' matches 'work effectively' on the recording; 'needed' matches 'have to have'. 'A' before the gap in the notes shows you that you need to write a noun here, not a verb or adjective.

38 Answer: airliners

Note You need to find the first of two causes here. 'Success of' in the notes matches 'speed and popularity of' on the recording. The fact that airships 'appeared superseded' matches 'stopped because of' in the notes.

39 Answer: crashes

Note You need to find the second of two causes here. 'Series of' in the notes matches 'number of alarming' on the recording. This is in the context of 'the decline of' the airship and the fact that this 'put people off'.

40 Answer: cargo

Note 'Recent interest' in the notes matches the idea that 'their popularity seems set for a slight revival and in the past few years there has been renewed attention paid to the possibility of' on the recording. 'Transport' can be a verb or a noun; on the recording it is a verb and would not be a correct answer for the space in the notes. The note is about the specific 'cargo', not passenger(s), that may be carried.
